Who is the MBDA?

- The U.S. Department of Commerce, Minority Business Development Agency (MBDA) is the only federal agency solely dedicated to the growth and global competitiveness of minority business enterprises. What are MBDA CRR Centers?
 - Utilizes funds from the American Rescue Plan for MBDA Business Centers throughout the USA to implement projects that will assist all BIPOC-owned businesses in preventing, preparing for, and responding to the COVID-19 pandemic.
 - Will operate from 7/1/2021-6/30/2022

What is the Philadelphia MBDA CRR Center?

- Operated by The Enterprise Center
- No geographic restrictions on services
- All services are free to BIPOC-owned businesses who engage with MBDA-CRR

Background and Approach

The MBDA CRR Team has extensive experience helping small businesses pivot and recover from COVID-19. **Over the previous year, the team:**

- Assisted 878 small businesses
- Supported small businesses in acquiring over \$10M in PPP & grant funding, including partnership with CraftNOW's CapitalNOW initiative
- Facilitated 28 training sessions
- Completed 50 recovery plans for small businesses




Service Model


